- Examination of significant provisions of the Tax Relief and Health Care Act of 2006, signed into law on December 20, 2006.
- Discussion of Rainbow Tax Service Inc. v. Commissioner, 128 T.C. No. 5 (2007), holding that a taxpayer's tax return preparation services constituted services within the field of accounting and therefore taxpayer was a qualified personal service corporation for purposes of I.R.C. § 448(d)(2).
- Coverage of new Proposed Treasury Regulations which provide guidance on S corporation family shareholder rules and the allowance of suspended losses to the spouse or former spouse of an S corporation shareholder, among other matters.
- Discussion of Proposed Treasury Regulations that provide guidance on issues involving the active trade or business requirement under I.R.C. § 355(b), including guidance resulting from the enactment of I.R.C. § 355(b)(3).
- Rev Rul 2007-8, 2007-7 I.R.B. 469 discussing the inapplicability of I.R.C. § 357(c)(1) to certain transactions that qualify as reorganizations regardless of whether they are also exchanges to which I.R.C. § 351 applies.
